Your Excellency,

"The United Nations must deliver results for a safer, healthier, more prosperous world. On this UN Day, I call on all partners and leaders to do their part and keep the promise."

These were your words almost year ago (2008 Oct.24). We agree with you. Even though we are but some of many Macedonians worldwide and not heads of state, just days before UN Day 2009 we are addressing you with note that we are keeping our promise.

In these politically, economically, socially and environmentally uncertain times, when the whole of humanity is facing many daunting challenges, your commitment to accept this noble calling and to lead the UN on the path of the universal and eternal ideals of peace, democracy, justice and freedom for all mankind.

The UN and its UN Security Council are regarded as authoritative body that should uphold the International law as the paramount guide for its actions and to promote stability and peace in every part of the World.

Let us not forget that stability of a country is not only its physical security and political stability translated as absence of foreign challenges of its legitimacy or name, invasion, war or civil war, intact borders on paper and political rhetoric about agreement and cooperation between major political players and politicians... but stability rather is condition in which all of the institutions of the country are functioning in harmony and in accordance with the Constitution and the law starting from its President, Prime Minister, Parliament, Representatives, the Government, Economy, Health Care, Education, Police, Military, Spiritual leaders ... and its key institution the citizen as the very cell of the complex organism called a country.

Country with all of those institutions under the pressure from outside "factors" called "international community" that are forcing the same institutions to violate the Constitution and to act against the national strategic security interest and against the free will of its people cannot claim physical security and political stability, nor can be productive or prosperous for the benefit of its citizen.

Your Excellency,

Isn't this exactly what we are faced with in the Republic of Macedonia? This has not started yesterday and the UN has its part in the evolution of the challenging problems ahead of us.

The illegal war on Yugoslavia from 1999, doomed to destabilize the entire region and followed by the not fulfilled UN Resolution 1244; Instead of affirmation of leadership for the UN, the building of new Albanian Nazi state in the area was concocted, one with its own army (KPC) consisting and lead by former terrorist only to be placed on a UN payroll. The attack on Macedonia that came from Kosovo and with incriminating participation by members of KPC, (Kosovo Protective Corps, at the time under UN protectorate) along with unfulfilled guarantees by NATO (while having US presence in Kosovo -"Bond Still") for Macedonia... all that has reflected on today's Macedonia's state of the State/ This has disappointed and angered in disbelief the peace loving Macedonians.

The agreement for the demarcation of the border between Republic of Macedonia and the successors of the former Yugoslavia (Serbia etc.) in its part with Kosovo (and Metohija) was deposited with the UN Security Council and guaranteed not to be changed.

What we have witnessed in past few days (October 17/18 2009) was obvious exchange of territory between Republic of Macedonia (UN Member, admitted in to membership under temporary name as FYR of Macedonia- we feel in violation of the UN Charter) and Republic of Kosovo (non member state and UN Protectorate that came out of unfulfilled UN Resolution 1244).

This exchange of territory took place under unprecedented pressure by the so called "international community" and in circumstances that are all but normal and are in fact illegal. We should mention recent calls by the political leaders of Albania for burning of the Macedonian flag in Macedonia by the Albanians. This was subsequently performed in a ceremonial fashion on the sport stadium in Prishtina (Kosovo) in front of large cheering crowd).

The vote and exchange of territory comes after late night rush vote (before midnight) only after recent armed attack on the Macedonian border police patrol from the direction of Kosovo (if judged by the evidence gathered it was by miracle that they survived the attack), exchange that was voted on in the Macedonian Parliament and is in clear violation of the Constitution of Republic of Macedonia and in violation of UN Security Council's decision and the deposited agreement for the border demarcation mentioned above.

The vote in the Macedonian parliament with presence of US and EU ambassadors and with absence of Macedonian Prime Minister, while the President of Macedonia is out of the country, plus without proper vote and procedure, is illegal and in clear violation of the Constitution of the Republic of Macedonia (Art.74).

Your Excellency,

Are the UN and its Security Council aware of these facts? Will your Excellency let this slide unnoticed? Will you join the crowd of those from the so called “international community” in congratulating the “amendable leaders” for the crime they are committing, or will you issue a public statement in defense of the integrity of the UN and its Security Council?

While the Macedonian political leaders from the opposition and from the Macedonian Diaspora are going through the legal appeal process in contesting this breach of our country’s Constitution and the breach of the International law, we ask for your help and support in preventing breaching of UN and UN Security Council’s stance on this issue with potential of having serious consequences for the World’s peace and stability, especially in the Balkans.

This is especially important for the UN’s image after all the havoc around Kosovo and the arising legal claims by Macedonians (and alike) for the consequences they have suffered as a result of the failed principles of the international politics, NATO’s involvement in the region, and last but not list the failed and unfulfilled UN Resolution 1244.

Your Excellency,

This latest havoc about the demarcation of the border between Macedonia and Kosovo is but another blow to the injury and our centennial wounds by the hand of the so called “great powers”, time of darkness when UN did not exist. This was another reminder of our own past and very recent never-ending process of suffering the ethnic cleansing and genocide by the hands of the merciless predators portrayed as the Albanian demographic violent wave.

Another éclat ant example is the Macedonian Encyclopedia that was doomed to be the victim of the same predators, publication by the Academy of Arts and Sciences that had to bend its spine in front of Taliban behavior of its opposition and not to say a word about the ethnic cleansing and genocide that took place inside of the Republic of Macedonia, and not only in the territory of Macedonia presently under the control by Greece.
